

- b. 4. What Information We Collect

- a. Codero may collect and retain the following information for customers and/or contacts

 - ii. Address
 - iii. Telephone number(s)
 - iv. Email address
 - v. Credit card number

5. Cookies

a. Information obtained through cookies, URLs, web beacons, pixel tags and other web identifiers we receive from visitors to our website does not identify you personally.

6. Third-Party Disclosures

- a. Codero does not sell or rent any personal data we collect to third parties. However, we may disclose or transmit personal data to third parties for specific purposes and situations, including:
 - i. To public authorities, in response to lawful requests, including to meet national security or law enforcement requirements;
 - ii. To litigants in response to a subpoena, court order, or other valid legal process;
 - iii. To business partners who assist us in processing and/or collecting customer payments;
 - iv. To third-party vendors to enable them to provide specific services to Codero, including, among others, retargeted ad placement services and website tracking, recording, testing, and optimization services;
 - To our attorneys and other third-party business partners, to prevent, investigate, or stop illegal or malicious activities including violations of our acceptable use policy, threats to our facilities, and threats to the physical safety of any person;

8. Data Storage and Retention

a. Personal data will be stored on our internal business support systems at our Phoenix, Arizona datacenter. Some of the above third-parties who may receive personal data under this Policy are also located outside of the European Union. Personal data will be stored for the duration of any applicable contract(s) and for a period of no more than seven (7) years thereafter.

9. Your Rights With Respect to Personal Data

- a. If applicable, you have the right to:
 - i. obtain access to your personal data and information about the processing thereof;
 - ii. ask for incorrect, inaccurate or incomplete personal data to be corrected;
 - iii. request that personal data be erased when it's no longer needed or if processing it is unlawful;
 - iv. object to the processing of personal data for marketing purposes or on grounds relating to yourparticular situation;
 - v. request the restriction of the processing of your personal data in specific cases;
 - vi. receive your personal data in a machine-readable format and send it to another controller ('data portability'); and
 - vii. lodge a complaint with an EU Data Protection Authority.
- b. If applicable, you also have the right to:
 - i. withdraw consent to processing of your personal data at any time;
 - ii. provided that, in such case, you will be unable to continue using the Services, and the customer with which your personal data is associated (if other than you personally) will be required to provide substitute information to continue as a Codero customer.
